## FRIENDS OF THE PATTERSON LIBRARY MINUTES November 9, 2020

<u>CALL TO ORDER</u>: The meeting was called to order by President, Susan Guest, at 1:00 PM on Zoom. (There have been no in-person meetings since March because of the pandemic.)
